- SUBJECT: Toastmasters International Bylaws proposed change to increase dues

During its February 2005 meeting, the Board of Directors decided that an increase to dues is necessary. This will require changes to the Bylaws of Toastmasters International, to be presented to the delegates for a vote at the 2005 Annual Business Meeting on August 26 in Toronto, Ontario, Canada. The Board of Directors recommend that votes are cast "FOR" this proposal.

The Board of Directors drafted the proposal to increase members' fees only after careful study and consideration. In the years since the last dues increase in 1992, the organization has enjoyed significant growth in new clubs, membership and sales from the supply catalog, our three main sources of revenue. In spite of this, the increasing costs of supplies, materials, labor and postage have outpaced our income growth.

As the current leaders of this organization, you, more than anyone, understand how our organization operates and the funds needed to provide services to members, clubs and districts, not to mention create and produce new and exciting programs that benefit all members. In addition, districts need more funds to better serve existing clubs and to build clubs so more people can receive the life-changing benefits of Toastmasters.

The last dues increase was almost 13 years ago. Through diligence, we have been able to postpone a dues increase until now. However, it is time to bring this matter forward to the membership for a vote....and we need your support and the support of the incoming district governor who will be carrying the proxies to the International Convention in Toronto to ensure the proposal is approved.

Districts have also gone almost 13 years without an increase in funds. A dues increase will provide additional funding for districts so they can better achieve the District Mission and the Toastmasters
